- Hotel is on right. (Turn right at the first traffic light into service road.)

From the South

- I-95 North to the Capital Beltway
- Continue I-95 North to Exit 19A (US 50 East)
- Follow U.S. 50 East toward Annapolis
- Take Exit 13A (U.S. 301 South)
- Hotel is on right. (Turn right at the first traffic light into service road.)
